Description of the camp: Riverlea, LLC (DBA Camp Riverlea), located on South Lowell Road off of Guess Road, north of Durham, NC has approximately 100 acres of rolling fields bordered on two sides by the Little River. Miles of woodland trails, two swimming pools, a pond, a camping lodge and open play spaces make it an ideal country camp location. Riverlea, LLC provides a wide range of camping activities including classes in swimming, archery, canoeing and kayaking, nature, music, arts & crafts, athletics, drama, games, golf and tennis. Each session, the camp experience includes one longer day where campers celebrate with a cookout dinner and twice during the summer older campers are invited to spend the night. The camp, established in 1971, serves Durham-area children, many of whom return every summer to carry on the camp tradition.

General responsibilities: A junior counselor at Riverlea, LLC is paired with a mentor staff member to be trained as a counselor. He/she must be able to assist in small and large group activities, supervise campers participation in structured and unstructured activities, demonstrate sensitivity to the needs of the campers, interact appropriately with campers in a variety of situations, appropriately model behavior and use positive behavior-management techniques. A junior counselor must possess the strength and endurance required to maintain constant supervision of campers while on duty and possess enthusiasm, patience, self-control, and a sense of humor.
